ORDINANCE 2015:05

AN ORDINANCE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF PARSIPPANY-TROY HILLS, COUNTY OF MORRIS, STATE OF NEW JERSEY, TO AMEND AND SUPPLEMENT CHAPTER 290 ENTITLED PARKS, RECREATION AREAS AND PUBLIC LANDS, ARTICLE I OF THE CODE OF THE TOWNSHIP OF PARSIPPANY-TROY HILLS

WHEREAS, the Township Council of the Township of Parsippany-Troy Hills wishes to update various fees charged pursuant to the Code of the Township.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Parsippany-Troy Hills, Morris County, as follows:

SECTION 1. Chapter 290 entitled "Parks, Recreation Areas and Public Lands," Section 290-4 entitled "Knoll Country Club Utility Fees" of the Code of the Township of Parsippany-Troy Hills is hereby amended and supplemented as follows:

- A. **§290-4, A. Knoll West.** The schedule for Greens Fees shall be deleted in its entirety and replaced as follows:

- A. **§290-4, A. Golf Carts** shall be deleted in its entirety and replaced as follows:

Golf Carts

9-hole	\$17.29 plus state tax of \$1.21 = \$18.50
9-hole ½ Cart	\$8.64 plus state tax of \$.61 = \$9.25
18 hole	\$29.44 plus state tax of \$2.06 = \$31.50

18-hole ½ cart	\$14.72 plus state tax of \$1.03= \$15.75

B. **§290-4, C. Notes** are hereby amended to include the following new numbers (14) and (15) and shall read as follows:

(14) Member dependent children and grandchildren under the age of 22 shall pay resident rates for all greens fees and golf cart rentals at the West Course. Proof of age is required. Member required to be present during golf play for dependent children and grandchildren.

(15) Daily/Weekend After Hours Times shall be as follows: March 1st – March 31st and October 1st – December Closing: after 1:30 p.m.; and April 1st – October 14th after 3:30 p.m.

SECTION 2. If any section, paragraph, subsection, clause or provision of this ordinance shall be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this ordinance as a whole or any part thereof.

SECTION 3. All ordinances or parts of ordinances of the Township of Parsippany-Troy Hills heretofore adopted that are inconsistent with any of the terms and provisions of this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4. This ordinance shall take effect immediately upon its final passage, approval and publication as provided by law.
