TOWNSHIP OF PARSIPPANY-TROY HILLS MORRIS COUNTY, NEW JERSEY ORDINANCE NO. 2015:25

AN ORDINANCE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF PARSIPPANY-TROY HILLS, COUNTY OF MORRIS, STATE OF NEW JERSEY, TO AMEND SECTION 405-36, CONTROL FOR THE MOVEMENT OF AND THE PARKING OF TRAFFIC ON PUBLIC AND PRIVATE PROPERTY, OF THE TOWNSHIP CODE

WHEREAS, the Township of Parsippany-Troy Hills (the "Township") controls the movement and parking of vehicles and traffic on certain public and private property; and

WHEREAS, the control of the movement and parking of vehicles is in the best interest of the health, safety and welfare of Township residents.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Parsippany-Troy Hills, Morris County, as follows:

SECTION 1. Section 405-36(A)(1)(d) of the Township Code, Control of the movement and the parking of traffic on public and private property, is hereby amended and supplemented as follows:

(d) Property: Parsippany Museum / 320 Baldwin Road.

[1] Regulations

[a] General parking.

[i] Parking prohibited during certain hours. No person shall park or cause to be parked any vehicle or vehicles on the premises of the Parsippany Museum between the hours of 1:00 a.m. through 6:00 a.m.

[ii] Permit parking. The parking of vehicles displaying valid unexpired parking permits issued by the Parsippany-Troy Hills Board of Education or its designated agent shall be permitted on the premises of the Parsippany Museum, but only during those times within the regular school year when Parsippany High School is in session, during which time the parking of vehicles displaying valid unexpired permits issued by the Parsippany Historical and Preservation Society shall also be permitted.

[iii] Tow-away zones. Any vehicles parked or standing in violation of the provisions of this section, or as to obstruct or impede a normal flow of traffic, block entrances or exitways, loading zones, reserved parking stalls, pedestrian walkways, or present in any way a safety or traffic hazard, may be removed by towing the vehicle at the owner's expense.

SECTION 2. If any section, paragraph, subsection, clause or provision of this ordinance shall be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this ordinance as a whole or any part thereof.

SECTION 3. All ordinances or parts of ordinances of the Township of Parsippany-Troy Hills heretofore adopted that are inconsistent with any of the terms and provisions of this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4. This ordinance shall take effect immediately upon its final passage, approval and publication as provided by law.
