**AN ORDINANCE OF THE TOWNSHIP OF PARSIPPANY-TROY HILLS,
COUNTY OF MORRIS, NEW JERSEY AMENDING, CREATING AND
SUPPLEMENTING SECTIONS 145-5 ENTERTAINMENT
ESTABLISHMENTS; 381-5 TOURIST ACCOMMODATIONS; 95-3
AUCTIONS; 372-8 TAXICABS AND LIMOUSINES; 296-3 CANVASSERS,
SOLICITORS, AND MOBILE VENDORS; 275-8 OUTDOOR EATING
ESTABLISHMENTS; 83-3 ALCOHOLIC BEVERAGES; AND A445 FEES
COMPILATION OF THE CODE OF THE TOWNSHIP OF PARSIPPANY-
TROY HILLS**

WHEREAS, the Township of Parsippany-Troy Hills (the "Township") wishes to update its Ordinance regarding several Township fees; and

WHEREAS, it is in the public interest to modify fees periodically for the Township to adequately cover processing and monitoring costs in regards to certain licenses and regulated activities; and

WHEREAS, the proper regulation of such activities and occupations is required in the interests of the health, safety and welfare.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Parsippany-Troy Hills, County of Morris, State of New Jersey as follows:

SECTION 1. Chapter 145, Entertainment Establishments, Section 145-5, License fee, duration of license, of the Township Code, is hereby amended as follows:

- A. The fee for the entertainment license shall be \$1,000.00 per year or any part thereof. The fee shall accompany the application for the license.

SECTION 2. Chapter A445, Fees Compilation, Section A445-20, Entertainment establishments, of the Township Code, is hereby amended as follows:

License fee: \$1,000

SECTION 3. Chapter 381, Tourist Accommodations, Section 381-5, Fee, of the Township Code, is hereby amended as follows:

The annual fee for a license shall be \$23 per lodging unit. If a license is issued after July 1, the fee shall be \$13 per lodging unit.

SECTION 4. Chapter A445, Fees Compilation, Section A445-72, Tourist accommodations, of the Township Code, is hereby amended as follows:

- A. License fee: \$20 per lodging unit annually.
- B. Issuance of license after July 1: \$13 per lodging unit annually.
- C. Transfer of license fee: 20% of annual license fee.

SECTION 5. Chapter 95, Auctions, Section 95-3 License Fee for Public Auctioneers, of the Township Code, is hereby amended as follows:

- A. The license fee for public auctioneers shall be \$75 per day for each day the license shall be in force.

SECTION 6. Chapter A445, Fees Compilation, Section A445-6, Auctioneers and auction businesses, of the Township Code, is hereby amended as follows:

- A. License fee for public auctioneers: \$75 per day for each day the license shall be in force.

SECTION 7. Chapter 372, Taxicabs and Limousines, Section 372-8 Limousine owner's license, of the Township Code, is hereby amended and supplemented as follows:

- I. Administrative fee. Each applicant shall pay a \$500 initial administrative fee for its initial limousine owner's license application. The administrative fee for each renewal of a limousine owner's license shall be \$250.
- J. License term. All limousine business licenses and vehicle licenses shall expire on December 31 following the date of issue and shall be renewed annually on or before January 1.
- K. Liability insurance and power of attorney.

- (1) No limousine business license or limousine vehicle license shall be issued until there is submitted to the Township Attorney, and approved by him as to both form and sufficiency, and filed with the Township Clerk at the time application for a license is made an insurance policy with the premium prepaid thereon issued by an insurance company duly licensed to transact business under the laws of the State of New Jersey with a policy limit of not less than \$1,500,000 against loss imposed by law, including but not limited to judgment or settlement, upon such owner for damages on account of bodily injury, including death, or property damage suffered by one or more persons arising from or caused by any one accident, including an act or omission, occurring by reason of the ownership, maintenance or use of the vehicle so licensed within the Township. A "combined single limit" policy in the amount required by this Code section shall satisfy this Code section. The operator of each limousine shall be covered by the insurance requirements herein referred to.
 - (2) All limousine business licenses and limousine vehicle licenses shall be effective and operative only as long as such insurance policy or policies remain in force and effect.
- L. Transfer of limousine vehicle license. Limousine vehicle licenses may be transferred from one vehicle to another belonging to the same limousine business license holder only after an application in writing has been submitted to the Township Clerk, on forms provided, along with a transfer fee of \$10. Limousine vehicle license transfer applications must be accompanied by proof that the license plates of the prior limousine were surrendered to the appropriate motor vehicle agency, and shall be accompanied by proof of insurance for the limousine vehicles to which limousine vehicle licenses are transferred. All limousine vehicles to which limousine vehicle licenses are transferred shall be inspected by the Township Police Department to verify that the limousine vehicle is in operational condition and complies with the requirements of the New Jersey Motor Vehicle Law. Approval of the Township Council shall not be required as a condition for the transfer of limousine vehicle licenses under this section.
- M. Additional rules and regulations. In addition to the rules and regulations set forth herein, the State of New Jersey and the Motor Vehicle Commission have further statutes, rules and regulations with regard to the operation of limousines and the conduct and licensing of operators thereof. The Township Council may, by resolution, make such rules and regulations in relation to the operation of limousines and the conduct of operators thereof as they may determine to be necessary and proper in the best interests of the Township. A certified copy of any such resolution shall be forwarded to all licensees within 10 days following adoption.

SECTION 8. Chapter A445, Fees Compilation, Section A445-39, Limousines, of the Township Code, is hereby supplemented as follows:

- D. Administrative fees.
- (1) Initial administrative fee: \$500.
 - (2) Administrative fee on yearly renewal: \$250.

SECTION 9. Chapter 296, Canvassers, Solicitors and Mobile Vendors, Section 296-3 Fee, of the Township Code, is hereby amended as follows:

A fee of \$350 shall be paid for each license applied for, and no more than one individual can utilize any one license. Any veteran who holds a special license issued under the law of the State of New Jersey shall be exempt from the fee but shall be required to comply with all other applicable subsections of this article. Licenses shall be valid from January 1 through December 31 of the calendar year in which they are issued.

SECTION 10. Chapter A445, Fees Compilation, Section A445-43, Mobile vendors and solicitors, of the Township Code, is hereby amended as follows:

License fee: \$350 annually.

SECTION 11. Chapter 275 Outdoor Eating Establishments, Section 275-4 Application, of the Township Code, is hereby supplemented as follows:

F. Fee. Each applicant for an outdoor eating establishment license shall pay to the Township a \$100 application fee. The fee shall be non-refundable.

SECTION 12. Chapter A445, Fees Compilation, Section A445-58, Retail food-handling establishments, of the Township Code, is hereby supplemented as follows:

K. Outdoor dining license fee: \$100 per year.

SECTION 13. Chapter 83, Alcoholic Beverages, Section 83-3, Licenses, of the Township code is hereby amended as follows:

D. License fees. The annual license fees for the sale or distribution of alcoholic beverages in the Township shall be as follows:

Class of License	Annual License
Plenary retail consumption license	\$2,500
Plenary retail distribution license	\$1,930
Club license	\$150

SECTION 14. Chapter A445, Fees Compilation, Section A445-2, Alcoholic beverages, of the Township Code, is hereby amended as follows:

A. License fees:

- (1) Club: \$150 annually.
- (2) Plenary retail consumption: \$2,500
- (3) Plenary retail distribution license: \$1,930

SECTION 15. To the extent that any previous ordinance or resolution is inconsistent herewith or contradictory hereto, said ordinance or resolution is hereby repealed or amended to the extent necessary to make it consistent herewith.

SECTION 16. If any part(s) of this ordinance shall be deemed invalid, such part(s) shall be severed and the invalidity thereby shall not affect the remaining parts of this ordinance.

SECTION 17. This Ordinance shall take effect upon passage and publication in accordance with applicable law.
